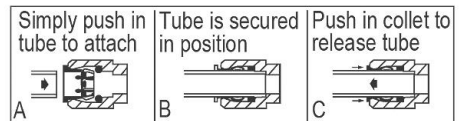

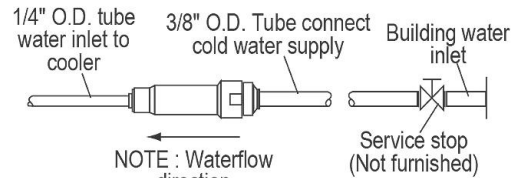

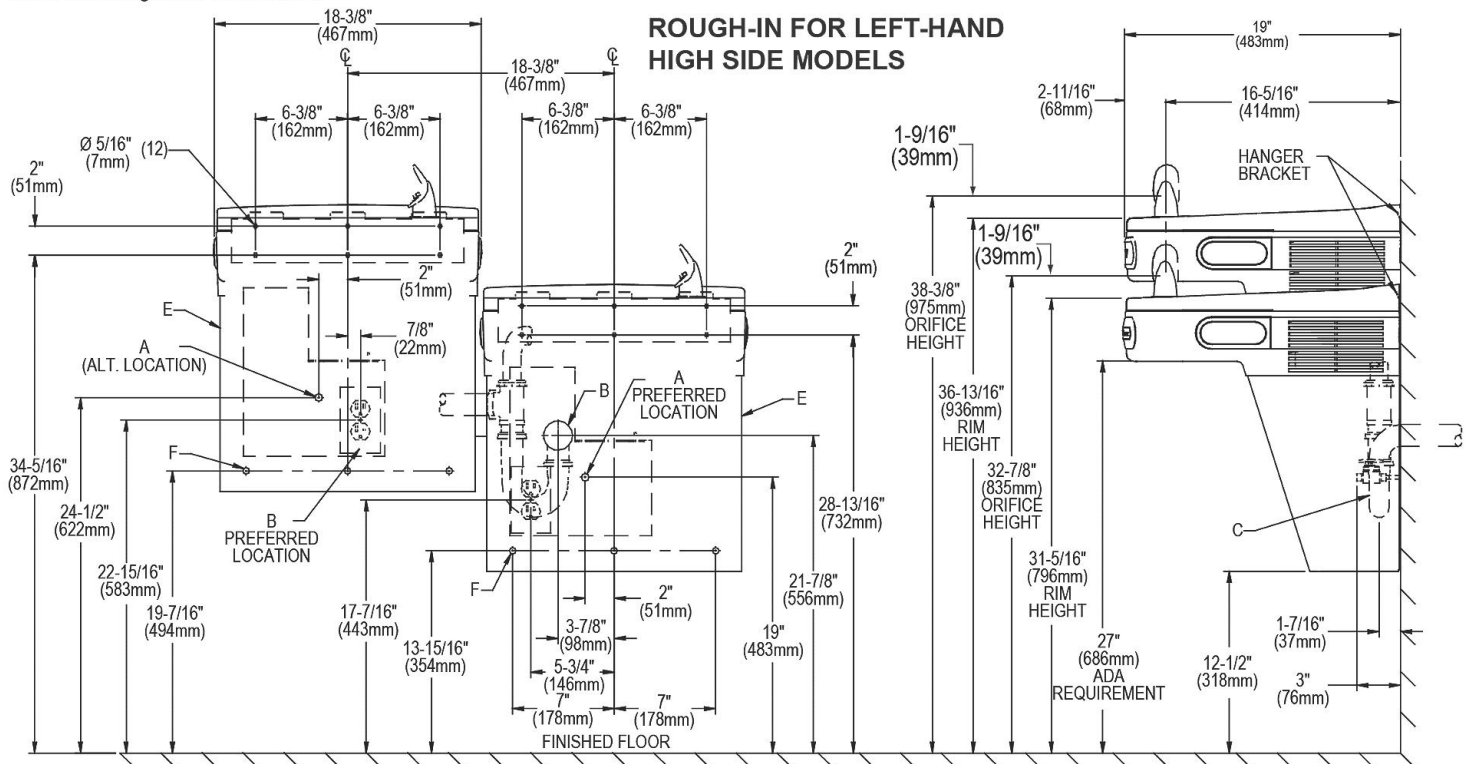
#### OPERATION OF QUICK CONNECT FITTINGS

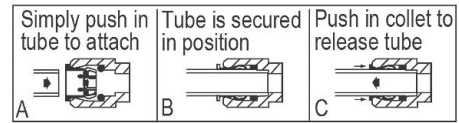

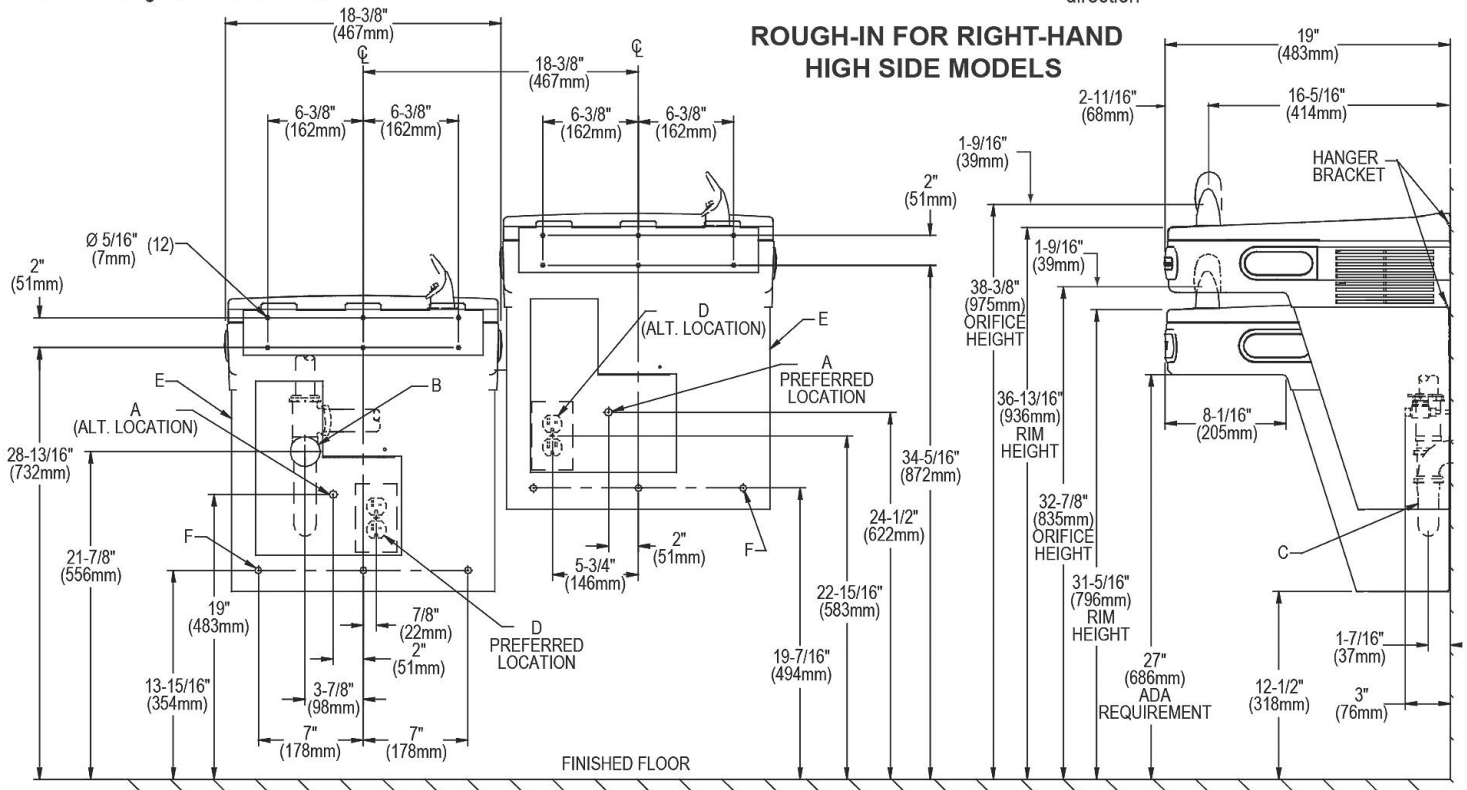
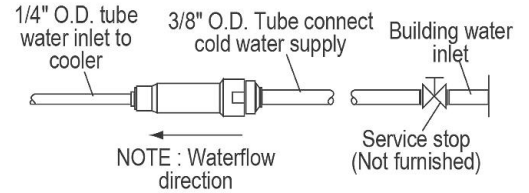
