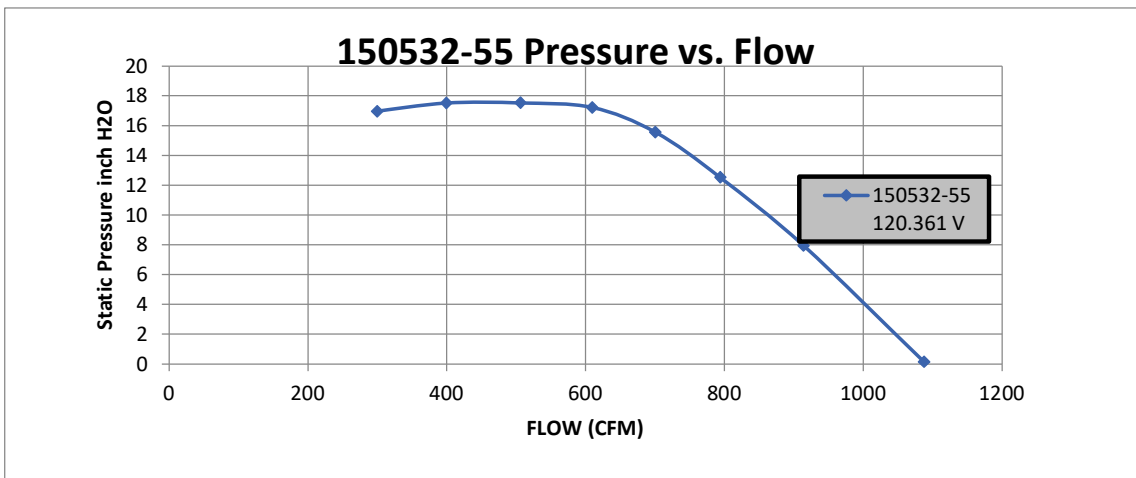

WARNING

DESIGN APPLICATION: Designed to provide variable airflow for low NOx and CO emission in high efficiency gas fired combustion systems. Built with non-sparking materials. Blower housing assembly constructed of die cast aluminum. Impeller constructed from hardened aluminum. Rubber isolation mounts built into blower construction to dampen vibration within the motor. Two-piece blower housing assembly sealed, and factory leak checked. Customer is responsible to check for any leakage once the blower is installed into the final application. This Blower is not designed to run above a 700 CFM operating point.

MISCELLANEOUS: Motor cooling inlet and discharge vents must not be obstructed. Motor ventilation air to be free of oils and other foreign particles. Blower is to be mounted so ventilation air cannot be re-circulated.
